<b>Additional information</b>	<p><b>ALUMINO SILICATES:</b> When alumino silicates have been exposed to service temperatures exceeding 982°C for prolonged periods, cristobalite, a form of crystalline silica may be formed. Exposure to cristobalite dust may cause pulmonary fibrosis-silicosis. A hazard is only anticipated during demolition of used refractory materials. Cristobalite is classified as carcinogenic to humans (IARC Group 1).</p> <p><b>REFRACTORY BRICKS:</b> These bricks are used for use in high temperature applications. They are typically composed of alumino silicate complexes. They may only present a hazard if cut, drilled, sanded or abraded, thereby generating dust. After use at high temperatures the surfaces will contain high percentages of free silica. Precautions should be taken during maintenance, brick replacement or demolition to avoid dust exposure. Do not stack &gt; 3 high on pallets.
