<b>Acute toxicity</b>	No known toxicological effects from this product. Based on available data, the classification criteria are not met.
<b>Skin</b>	Contact may result in mechanical irritation, redness and rash.
<b>Eye</b>	Contact may result in irritation, lacrimation, pain and redness.
<b>Sensitisation</b>	Not classified as causing skin or respiratory sensitisation.
<b>Mutagenicity</b>	No evidence of mutagenic effects.
